This cross appeal is brought under s 101(2)(e) of the Supreme Court Act 1970 (NSW) and r 51.11 of the Uniform Civil Procedure Rules 2005 (NSW)

#### APPEAL GROUNDS

The primary judge erred in failing to find that [29(d)], read with [7], of the cross-respondents' Commercial List Response raised a matter capable of settlement by arbitration as a discrete controversy, which must be stayed pursuant to s 7(2) of the International Arbitration Act 1974 (Cth): cf Elecnor Australia Pty Ltd v Clough Projects Australia Pty Ltd [2025] NSWSC 610 at [105].

#### **ORDERS SOUGHT**

- Cross appeal allowed.
- Set aside order 1 of the orders made on 8 July 2025 and in its place order that:

  Pursuant to section 7(2) of the International Arbitration Act 1974 (Cth) and in
  accordance with clause 23.3 of the Transgrid Project Energy Connect Project Joint
  Venture Deed (as amended) between the plaintiff and first defendant, the matters
  raised:
  - a. in the cross-claim (excluding that raised by [15] of the Commercial List Cross-Claim Statement filed 14 March 2025); and
  - b. the claim by the defendants at [29(d)], read with [7], of the Commercial List Response,

be stayed.
